


Natura-areas are in general independent areas, but they can also overlap different ways.




SCI-area, with no connection to other NATURA 2000- areas (one code).




SPA-area, with no connection to other NATURA 2000- areas (one code).



SCI-area merged with a SPA-area (one code).




SCI- ja SPA-areas area connected, but are not overlapping (two codes).




SCI-area, including a SPA-area (SPA-area is on top of the SCI-area, two codes).
